### Case 1

Read this scenario:

"In the city of Beirut, Khalil's parents came from different religious communities. The country's leaders agreed that the President must be Maronite Christian, the Prime Minister should be Sunni Muslim, the Deputy PM an Orthodox Christian, and the Speaker a Shi'a Muslim. This arrangement continues even though now Muslims are the majority."

- (a) Why can't Lebanon be a "normal democracy" in the way many countries are?
- (b) What name is given to this system of allocating top posts by religious group?
- (c) Which type of diversity is involved in this example?

### Case 2

### Read:

"Sri Lankan Tamils demanded recognition of Tamil as official language, regional autonomy, and equality in jobs and education. But successive governments refused. By 1980s, Tamil parties demanded a separate Tamil Eelam state in north and east."

- (a) What is meant by "majoritarian measures" here?
- (b) Which type of power-sharing were the Tamils asking for?
- (c) Why did the refusal lead to conflict?

## Case 3

### Read:

"Belgium is a state where power is shared on linguistic basis. It has central, regional, and community governments. The

    - Reason (R): This is because democracy is the rule of the people, for the people, by the people.

    - Reason (R): Judges are superior and more experienced than the executive.
  - 3. Assertion (A): Social conflict often leads to violence and political instability.

- Reason (R): It brings disharmony among social groups and destroys peace.
- 4. Assertion (A): Imposing the will of the majority over minorities undermines national unity.

  Reason (R): It divides even the majority community itself.
- 5. Assertion (A): In Belgium, both linguistic communities have representation even in the capital region, Brussels. Reason (R): This ensures that the minority group does not feel excluded.
