Mona purchase a goods from Heena on 2<sup>nd</sup> February for Rs. 9,200 and endorsed the first bill in full settlement. On the due date sona honoured the first bill and unable the pay second bill. Heena paid Rs. 50 as noting charges. After 15 days Sona paid full payment to Mona with interest of Rs. 60. Pass the necessary journal entries in the book of Mona.
